Our economy during the conflict period was also managed better than many peer economies. Presently Sri Lanka is one of the best performing economies in the region.

"As a country, we have improved the investment climate as reflected in the 'Doing Business Index' which is compiled by the World Bank. I believe that the CAAYE alliance can play a major role in developing young entrepreneurship through their member countries including Sri Lanka."

CAAYE Founder President Dr. Rahul Mirchandani, addressing the gathering, stressed that Asia is fast changing with the region contributing 60% to the world's GDP, but trading within the member countries is very low. It set out recommendations to member governments to support entrepreneurs whose businesses help address the country's development needs. The communiqué was signed by the country representatives and presented to Regional Director

Aminul Islam Khan for submission to the member governments.

FCCISL Secretary General/CEO, Nalin Attygalle in his concluding remarks stated: "What a coincidence it was to have a CAAYE summit finale at a venue that has been created by an outstanding entrepreneur/businessman Raja Mahendran. Stein Studio is one of the largest in the Asian region having all facilities in accordance to international standards."

Attygalle also stated that the CAAYE should publish its annual activity calendar and all member countries should have the reciprocal connectivity through the web. The G20 Alliance should take an active role to support all young entrepreneurs and SAARC young entrepreneurs will be the newest group that will link with the team.
